Terms and conditions

1. **UOS** recognises the above programme(s) and will offer places on the above UOS programmes to suitably qualified students, subject to availability.
2. Students will be considered suitably qualified if they have met the conditions, if any, stated in the table above.
3. Evidence of one of the following English qualification is required unless stated differently in the conditions:
 - a) IELTS Band 6.0 (with 5.5 minimum in all components) or above. Some programmes might require IELTS 6.5/IELTS 7.0.
 - b) An equivalent qualification

If the student's English language attainment is lower than the required standard, s/he must attend specified English for Academic Purposes University Pre-sessional (EAP Pre-sessional) courses at UOS prior to commencement of their programme.

4. Applicants for programmes at UOS will be required to comply with any University procedures currently in force.
5. UOS reserves the right to decide not to run any programme(s) during the academic year notwithstanding that they were included in any prospectuses supplied to Chihlee University of Technology as much notice as possible will be given to Chihlee University of Technology of any such decision.
6. In the event of the programme structure changes from Chihlee University of Technology, Chihlee University of Technology will provide UOS with copies of its programme documents/syllabuses for reviewing.
7. Students wishing to enrol for programmes at **UOS** other than those listed in this letter are welcome to apply. Such applications will be considered on an individual basis.
